It will ask for members ideas for future events as well as timings, location etc. Ideas put forward included a social lunch/tea, a visit to Bletchley, a tour around the British Library, the Shoreditch Area from a foodie perspective and a talk plus Q&A session either in person or as a webinar. It was also suggested that we perhaps look into holding a biannual event with Apollo 19 but also make sure we liaise with Apollo 19 before confirming events so diaries don't clash.

Chairman Laura thanked Camilla for her work on events and leading this discussion and also members for their contributions.

There was no other business apart from Sara Cooke thanking the Committee for their hard work for the Association.
